# II. PUBLIC INPUT FOR ITEMS NOT LISTED ON AGENDA (3 Minute Limit) - None

## III. STUDENT COUNCIL INPUT

- Brian Forgue said winter sports have wined down. Brett Bonenfant and Garret LaBranch qualified for western mass wrestling. Today Dr. Hopson announced out of district field trips have been cancelled to include the senior trip and talent show. Band concerts and the play will not have an audience. No one was pleased, especially not the senior class. It's their last high school everything. He has two questions. One, if by some miracle the corona dipped to a low number and is no longer a public health crisis, could some of the later activities can be reestablished. Two, is there a plan for seniors and those who already paid for things to get reimbursed.
- Dr. Hopson said yes, if the governor declares the state of emergency is over, we could reestablish activities. We essentially cancelled activities now in order to be able to get money back. If we didn't do that and the

governor extends the state of emergency, then we wouldn't get money back. An example is the DC trip. Graduation at this point is not cancelled. It will depend on the recommendations of the state. He suspects the governor will cancel athletics. We have done what the state has recommended.

- Mrs. Crane thanked Brian for sharing the real opinion. We really appreciate it.
- Dr. Hopson said one of the things that hasn't been brought up yet is what we are going to do with town meetings if this continues.
- Mr. Forgue said these are recommendations not mandates.
- Dr. Hopson said yes, but if we don't follow the recommendations and something happens, then that is
  another issue.

• Dr. Hopson said because we are getting all this extra money \$5 extra per student since we've already been held harmless, we have to create a plan for what we are going to use the money for. We will apply the \$25,000 toward the full-day preschool and vocational program. It fits in their neat categories. Part of the state's requirements are is to get public input.

#### B. Recommendation for Regional Transportation Bid

• Ms. Fisk said we spoke to our attorney and the IG's office and the administrative recommendation is it is in the best interest of the district to re-bid the transportation contract.

# Mrs. Nazzaro made a motion seconded by Mrs. Garfield to go back out to bid for the Regional Transportation Contract.

- Attorney John McLaughlin spoke on behalf of Lecrenski Bros. Dufour filled out their paperwork with horrible mistakes. His client pointed it out there were civil lawsuits and criminal accusations. Once Dufour was deemed nonresponsive, Lecrenski Bros. is the low bidder. His client shouldn't have to suffer through a re-bid. Someone came in here and tried to scam you. Now they know what our number is. That puts us in a terrible situation. They don't know why, but he has tried to contact Gateway's attorney and not heard back.
- Dr. Hopson said his inclination from the beginning was to re-bid. When we had contacted the IG's office we decided re-bidding is in the best interest of the district and the school committee has the right. Rebidding puts everyone in a difficult position.
- Ms. Fisk said you have to look at the series of bids from over the years. We've had to re-bid before. Lecrenski's bid is not a perfect bid either.
- Dr. Hopson said we believe it is in the best interest.
- Attorney McLaughlin asked if they are going to have to deal with Dufour again.
- Ms. Fisk said you may.
- Dr. Hopson said the change to the bid process is we are requiring a check rather than a bid bond.
- Attorney McLaughlin is asking not to re-bid.
- Mrs. Balboni said re-bidding just makes it clean.
- Mr. Forgue asked what was the reason?
- Dr. Hopson said there was a question about the bid bond.
- David Lecrenski said his dad started the business in 1988. Under 30 b, you can negotiate the difference. He is very surprised not to be asked to negotiate.
- Attorney McLaughlin was also surprised.
- Dr. Hopson said the numbers are part of it. He half expected it wasn't in Lecrenski's best interest to negotiate.
- Dr. Hopson said we could postpone until the next meeting or vote approve pending successful negotiations.

- Mr. Forgue asked who would negotiate.
- Dr. Hopson said Ms. Fisk and David Lecrenski.
- David Lecrenski said they just unionized up here last year. He is dealing with that right now.

Mrs. Nazzaro withdrew her motion. There were no objections.

Mrs. Nazzaro made a motion seconded by Mr. Forgue to approve awarding the contract to Lecrenski Bros. pending successful negotiations between the district and Lecrenski Bros.

- Mr. Forgue said is it successful if we agree the target is at least to match.
- Mrs. McVeigh said we have had them for years. Have we had any issues?
- Ms. Fisk said we haven't had any issues with any of them

#### **D.** Athletic User Fees Discussion

- Dr. Hopson said given Mr. Myers' and Mr. Forgue's recommendations. He would entertain a motion to eliminate under fees over the next two years. The budget would have to go up to cover them. As we drain the account, we will have to budget for them.
- Ms. McVeigh said so we are saying for FY '21 there will be no user fees.

Mr. Forgue made a motion seconded by Mrs. McVeigh motion to drop all athletic user fees.

- Mr. Forgue said the unemployment number is still sticking with him. He sees no justification in going from \$10,000 to \$60,000. We could simply transfer \$26,000 from the unemployment to athletics.
- Ms. Fisk said you can at the end of the year. We budget for professional staff who may not be employed at the end of the year.
- Ms. McVeigh said we pay our own unemployment.
- Mr. Forgue said we are paying our own unemployment. We anticipate laying off that many staff members.

- Dr. Hopson said every year we do this and discuss whether we are going to keep staff who are nonprofessional, etc.
- Ms. Fisk said you will have to have a transfer in the 4th quarter.
- Ms. Fisk said we are going to try to cover transportation costs with our own transportation. If we can cover transportation
- Mr. Forgue asked what was the difference in the bus bids.
- Ms. Fisk said \$14,000 in athletics and \$13,000 in special ed. We are at \$11,378 and we just got our bill for January. We will be paying that from January to June.
- Mr. Myers gave kudos to the administration for eliminating athletics. It is great for marketing.
- Ms. Fisk said the best marketing would be free the preschool.
- Mrs. Papillon asked about the other recommendation of reducing cheering to a spirit team. They wanted to have more of an opportunity to perform the rest of the year.
- Ms. Fisk said we should leave it in as an athletic team, and just add and advisor for the spirit part.
- Mrs. Foley said if they are a spirit squad does it stop them from competing.
- Mr. Finnie said yes, but they haven't been competing for many years now.

Mr. Forgue made a motion seconded by Mrs. McVeigh motion to drop all athletic user fees.

#### C. Extension of alternative learning days.

- Dr. Hopson said if you weren't on a pilot program before you couldn't use them. But if you have been part of the pilot plan, you can. March 15-June 1 days missed up to 5 have to be used up. After that we don't have to make them up. We are working with staff creating methods other than blizzard bags, so we can still educate students. We don't need to extend them.
- Brian Forgue does this new plan we have 5 additional days.
- Dr. Hopson said the plan is you have to go to the 185<sup>th</sup> day.
- Mrs. Balboni said to be mindful of social distancing. What about the kids who need care? She doesn't want kids' home without adults.
- Dr. Hopson said there are so many levels and so much is changing. As a leadership team they have been working with union. There are students We can only have an alternative lunch program anywhere except Chester. We have identified students that have services that are needed, or social or emotional needs. That would include us potentially bussing in the students. Trying to figure out how to make that work without

putting our staff at risk. Even working with HCHC the offices communicate between offices. There is a respiratory test that can be done. We have offered to pay for the test if it is not covered under health insurance, so we know.

- Mrs. Nazzaro do you think the recommendations would change for the lunch services.
- Dr. Hopson hopes that the state uses common sense. He said in a letter that went home, we have cancelled out of district field trips and the German trip coming here. We have kept after school activities and athletics are still on. Performances won't have an audience.
- Dr. Hopson said the state has not recommended to change athletic activities, but he suspects they will.
- Dennis Nazzaro said working with Huntington fire police, emergency management board of health. Consistent message to everyone priority. Get your information from state and CDC. If you contract it and are healthy, you will be fine. The concern is the young and elderly. Otis is out an ambulance and three EMT's.
- Mrs. McVeigh received an email from her corporate headquarters canceling all travel until June 30. They have increased screening protocols and they have changed cleaning protocols.
- Dennis Nazzaro said the first step was how to stop it, now how do we prevent it.
- Mrs. Otterbeck asked what that means if your student is coming home, are they going to be able to come back.
- Mr. Myers said the Maple Fest on Chester hill is cancelled.
- Mrs. McVeigh said Huntington is having annual town meetings discussions.
- Mrs. Garfield asked what the procedure is for reporting it.
- Dennis Nazzaro said it should be reported the CDC.
- Dr. Hopson said we have to ability to know which students are more susceptible. We are also working with GEA to identify staff that may be more susceptible.

- Mrs. Nazzaro said we are increasing the alternative method based on the statutory last year. Towns that saw a savings last year, their 1.96% is already less. They are seeing a benefit. The perception is different.
- Ms. Fisk said you also heard from a town Montgomery who said they would rather pay the high amount. There were people who said on town floor they thought we were going to try this for five years.
- Mrs. Balboni said Russell interprets it as let's look at it for 5 years we will see what happens and then we will decide.
- Mrs. Nazzaro said Mr. Baldasaro from Chester said he felt like this is a lost cause. She still feels like she wants to try to continue to keep this alive and show the communities they still find value in it. She likes that Huntington voted the alternative method and vote the higher amount.
- Ms. Fisk said one thing that came up is to push legislators to have 4 town instead of all approve the alternative method.
- Mrs. LeClair agrees we should continue to fight for it.
- Mrs. McVeigh said the select board might be willing to pay, but not necessarily the towns people. She will do her best but \$140,000 is crushing. This doesn't even include voke numbers.
- Mrs. McVeigh said they will get the alternative and the statutory numbers.
- Ms. Fisk said yes.
