#### C. MARS Recommendations

- Dr. Hopson talked about the MARS recommendations. A great many are in process or there is money set aside in the budget for next year. Regarding staffing we are looking at sharing ideas and getting input from the towns. We are looking at long-range capital needs and working with the towns. Is there something we can do with the budget process, a subset of school committee or the whole committee that would start meeting in September? We would contact the towns to get a representative for these meetings. Often administrators don't have a good handle that early. The budget changes pretty dramatically from when they start putting it together to the time it's handed out in February. School Committee should think about if they want to make it a subcommittee or include the whole committee.
- Mrs. Winer asked what he meant by having the selectmen. She is against having a separate subcommittee.
- Dr. Hopson said that is why he is suggesting the two options.
- Mrs. Crane thought regarding those four or so meetings starting in September we could do business the first half hour or so and then go into a big block of budget and complete more school committee business after depending on the time when budget is over. It also doesn't add meetings.
- Mrs. Austin asked how we propose getting people to come to the meetings.
- Dr. Hopson said once school committee decides, a letter would go out to the towns for them to select a representative.
- Mrs. Dunn thinks we should get the towns to committee 3 or 4 people to commit to all four meetings. We would give them all the stuff we get. So we aren't doing things over and over.
- Mrs. Crane agrees.
- Dr. Hopson said the other things we looked at were sharing and regionalization. A super-region is probably less viable than sharing services. He is in discussion with a superintendent about sharing a food services director. MARS suggested sharing the positions we don't have. Mike Buoniconti was looking at positions like payroll (things in his district), but we already have that person doing many things payroll, insurance, human resources, etc. Administrators are working on having teachers become more empowered. Mr. Finnie had developed some job descriptions for testing coordinators. We will be holding a 2025 meeting just for just staff next week, hoping to get ideas.
- Mrs. Winer asked what a super-region is.
- Dr. Hopson said we would have a school system from CT to VT, because we would have to combine with so many to get just under 5,000 students. We work with the collaborative for educational services. We

- have been talking with them to see if it would be worth it to join. If we were to join school committee would have a seat on the board and the superintendent would have seat on the board.
- Dr. Hopson said we've done the transportation study. Kurt has been working very hard to get students back
  in and keep them in. He would like to add this to the budget for the next meeting. Administrators added
  what they needed and Dr. Hopson tied them to the school committee goals. About half were high priority.
  Very few were low priority.

Put an optional meeting for next year in March we don't necessarily need to use.

### D. Business Manager

- Ms. Fisk said the new used van is out of the welding shop. They fixed the door where it was rusted on the bottom. It will be registered and we should be using it for special education transportation.
- Today, Ms. Fisk received a draft report of the auditor report so we will get that to school committee and see when they can come to do a presentation. The new firm picked up six new clients this year. They anticipate it being quicker next year.

## Budget

- Dr. Hopson handed out the new revised local contributions based on the March 1 census.
- Huntington and Russell have gone up a tad. School committee will be voting the bottom line of the budget.
  As we get the House, Senate, and final budget from the state, we will make updates. We have 15 members that are supposed to be on the committee, so we need 10 yes votes. If we can't approve a budget tonight, we will need a special meeting next week.
- Mrs. Foley asked about the change in populations, did her town lose students.
- Dr. Hopson said students keep enrolling at the elementary level. Ask Mrs. Coburn.
- Mrs. Coburn said she has three students enroll from Russell since March 1.
- Dr. Hopson said we have to send the statutory or the regional agreement as a school committee, but we can provide the five-year. If the towns want to look at that, and a town votes for the five year rolling average and all towns vote yes, we can move it forward and bring it to DOR.
- Dr. Hopson said only statutory doesn't have to be done yearly. Russell and Huntington have been hit really hard. The five-year rolling average takes the spikes out.
- Mrs. McVeigh said one of the ideas was that when you vote it you would vote for a 5-year period, so it would require special legislation.
- Dr. Hopson asked if the towns' would vote at annual town meeting, and then would it go to legislation.
- Mrs. McVeigh doesn't know. It may take longer than our couple of months but it is worth looking at.
- Mrs. Winer said the three route 20 towns have 75% of the populations.
- Mrs. McVeigh said the budget would be voted every year, but the formula wouldn't change.
- Dr. Hopson said Andy's other suggestion was just adding the assessment to the current amount allowing towns to know what to expect. Russell is paying \$5,000 less per pupil than Blandford.
- Mrs. Foley asked for the cost per student to send a student to Westfield or Smith Vocational.
- Mrs. McVeigh said Westfield is \$11,000 and Smith is \$17,000. That's for regular education tuition. There is a stipend for special education.
- Mrs. Foley asked about the per pupil cost by town.
- Ms. Fisk didn't know off the top of her head.
- Ms. Fisk said the 391 grant which funds our preschool will be reduced by 1/3 over the next three years and will be gone.
- Mrs. Crane said we need to vote on the teachers' salary line item without Mrs. Papillon here in the room.
   She has filed a disclosure and will recues herself as she has immediate family members working in the district.

Mrs. Papillon recues herself and left the room.

Mrs. Otterbeck made a motion seconded by Mrs. Balboni to approve the Chester teachers' salary line item of \$344,572 and the middle school nurses' salary line item of \$54,873.
