- Mrs. Crane opened the meeting at 7:06 p.m.
- Mrs. Buikus and Mrs. Austin are recording the meeting.
- James Duggan read a statement on behalf of teachers association with regards to the budget and negotiations.
- Cheryl Wright read a statement supporting the teachers and what a great school we have.
- Susan Rhoads read statement comparing teacher salaries.
- Rod Kleber talked about his history at Gateway and working together.

#### III. STUDENT COUNCIL INPUT

• Brennan Foley said the seniors started a Yankee Candle fundraiser today. They collected class dues of \$75. They are in the process of choosing a commencement speaker and looking into a senior trip. Dr. Seuss events will be happening in March. Six students went to honor band. It was phenomenal. They had a master class for each instrument and sectional. The cost was \$40 and the band boosters paid for half. The healthy relationships group continues. Model UN is selling carnations. Friday is spirit day and students are wearing pink and red. Skiing finished yesterday. The following skiers are going to states: Johnathan Rooney, Nick Herman, Jess Garriepy, Alison Garriepy and Shannon Burke.

# V. BUDGET

### A. FY '17 Budget

- Administrator Presentations
- Dr. Hopson said the court ruled we didn't have standing in anything we put forward in the lawsuit. Attorney's Dupere and Lampke are reviewing it now. Attorney Russell Dupere will be here at the next meeting for potential next steps.
- Mrs. Winer asked if the judge said why.
- Mrs. McVeigh said the legislature has the right to make general law. Education is the purview of the state
  so they have the right to pass general law. A lot of the issues are related to the breaking of a contract not
  necessarily education.
- Mrs. Crane said our attorney will be here for the next meeting to help us go over everything.
- Mrs. McVeigh would ask that Attorney Russell Dupere be prepared to discuss the cost of an appeal, plus the litigation. We will have to think about suing Worthington for their costs.
- Mrs. Buikus asked for a copy of the ruling.
- Dr. Hopson said he will share what we have. We only have information from the lawyer.
- Dr. Hopson said we have been carrying additional payments for those issues in the budget. How are we going to address that? For FY '17 we have included \$84,000 as revenue that Worthington has no intention of paying. It is for the Hampshire county retirement and the pay as you go insurance. We didn't get anything this year and they are not planning on paying next year. Only capital costs are included in the agreement. We have to adjust the budget.
- Dr. Hopson gave a brief PowerPoint presentation.
- Mr. Crochiere asked what is the benefit of getting rid of junior high?
- Dr. Hopson said when we split middle school and junior high we lost administrators. As population decreases we can fit 5<sup>th</sup> back in the elementary schools. There were concerns in the middle school there wasn't a teaming effort and they are happy to go back to the middle school model 6-8. We will have a principal in each building and will be able to eliminate a middle school office.
- Mrs. Coburn gave a presentation on the Prek-5 model of the budget.
- Mrs. Buikus asked if band and Chorus for 5<sup>th</sup> grade will be available for Chester.
- Mrs. Coburn said yes. Anything offered at one building will be offered at another.
- Susan Roads asked if we know how many students choice out of Littleville.
- Dr. Hopson doesn't know off the top of his head.
- Mr. Finnie gave a presentation for middle and high schools.
- Mrs. Winer asked if Mr. Finnie thinks he can make a good program with that grade configuration.
- Mr. Finnie thinks we can, we are stretched thin in some areas, but the other options don't support our students.
- Mrs. Winer asked about online courses.
- Mr. Finnie said we are more flexible with online courses, but they are mostly offered to juniors and seniors. We use a particular vendor and we offer students online courses for those courses we don't offer.
- Mrs. Austin asked if there is a state requirement for health.
- Mr. Finnie said there has to be PE, but health is not required.
- Mrs. McVeigh asked if a student participates in after school sports, do they have to take P.E.
- Mr. Finnie said we have looked into potential waivers for that, but at this point they are still required to take PF
- Mrs. Buikus asked if there are any courses we have had to think about cutting with the budget.
- Mr. Finnie said a 2<sup>nd</sup> level of health potentially. There are electives related to PE (bodies and brains, sports management). It also depends on what students sign up for. Wood shop may have fewer sections.
- Mrs. Buikus asked about AP courses.
- Mr. Finnie said right now we are trying not to touch those.
- Mrs. Winer asked how we are going to get along with fewer days for the sped administrator.
- Dr. Hopson said it won't be easy, but the new administrator will only be working a few less days. Their vacation time won't be the same and if you recall we are redistributed tasks.
- Mrs. Winer asked about the academic director.
- Dr. Hopson said it seems simple but as we continue to meet to go over tasks it becomes overwhelming.
- Mrs. Winer said we had two people doing that before.
- Dr. Hopson said we had a Math and ELA coach under Mrs. Blocker. A lot of decisions made have been made around keeping student services. We have a lower budget now than in 2003. When you cut administrators you have to rearrange. We try to avoid laying off staff, so you avoid paying unemployment.

Mrs. Coburn and Mr. Finnie indicated there is a lot of work to do, but we are still trying to move forward for the next few years. You have the budget and both Mrs. Coburn and Mr. Finnie will be available for questions at the next meeting.

Mrs. Foley made a motion seconded by Mrs. Otterbeck to go into executive session at or before 9:15 p.m. for the purpose of union negotiations not to return to open session.
