#### III. STUDENT COUNCIL INPUT

- Brian Forgue said learning is going good and he is looking forward to school over the
  next few weeks. The girls cross country team lost their last meet. The boys won their
  last two meets. There is a club meeting coming up. He said the nurse letter hit him pretty
  hard. Mr. Carlson has been a nurse for as long as he has been alive. If all this is true in
  what he said and he had to resign it concerns him. He would like to know more about
  this.
- Dr. Hopson said we had 15 people who asked for accommodations. Of those there
  were only two people who could work completely remote. It is hard to work all remote as
  a school nurse. He could have taken an unpaid leave, but he chose to retire.
- Dr. Hopson said under an unpaid leave he would have had to pay his share of the health insurance. We had to follow the law. We have folks that have to wear face shields and other PPE's as accommodations.

#### A. Education Foundation Update

- Dr. Hopson said they haven't met since Covid. They did fund the summer reading program at Chester and Littleville, purchased white boards for K, 1, and 2 and purchased a program called eSpark for 5th grade teachers. They opted not to fundraise because of Covid.
- Mrs. Balboni said they did a lot of work to hold a trivia night in May. They are in a financial position to give out grants in the fall. They would like to raise money and spirits.

#### **B. MASC Race Relations Statement**

- Dr. Hopson said we started with the one from MASC and Mrs. Crane re-wrote it completely. He asked if anyone had any suggestions or changes.
- Mrs. Balboni asked if hiring people of diversity and adding more diversity is something that we consider.
- Dr. Hopson said unfortunately the number of applications we get are low in general.

# Mrs. Foley made a motion seconded by Mrs. Balboni to support the Race Relations Statement.

- Mr. Forgue asked if Mrs. Crane had a chance to discuss this further with Parker.
- Mrs Crane said she sent him the information, but she never heard back from him.
- Brian Forgue thinks that Mrs. Crane changed what Parker wanted her to change.
- Mr. Forgue asked how we are overseeing this in the virtual environment. How do we
  handle a situation when a student leaves a discussion because the parent is
  uncomfortable with a conversion.
- Mr. Finnie said the teacher would reach out to the parent the idea is to have multiple viewpoints on a situation - part of the education process is to be exposed to multiple perspectives. They are not teaching one perspective only.
- Mrs. LeBlanc said we are reviewing curriculum for bias as a whole staff to address some
  of those issues.
- Mrs. Balboni asked how measurable is this goal.
- Mrs. Crane's idea this would show a particular attitude and idea about a tone about this item. She knows the administrators have ways to start working on this.

#### F. Town

- Mr. Forgue is curious. What recent and long term effect is if level service plus doesn happen
- Dr. Hopson said level service plus has already happened the rest runs out in December. At this point we are in decent shape. If we get additional money, it may help the second half of the year. The second half is pretty equal to what we anticipate.
- Ms.Fisk said it depends on how long we continue. For this year we are fine. The next school year is what we need to plan for. They are recommending to plan for a level service. We have a lot of homeschool students. That is going to impact our chapter 70 money.

- Mrs. Nazzaro said the bulk of the summary was a synopsis of the virtual offerings they
  had and also what they have been doing over the past several months. She will pull out
  the most relevant and participate to the fullest.
