- 1. Tasha Hartley asked how lunch was going to work. It looks very different in the cafe versus the classroom.
- 2. Megan Coburn was thinking she would have paraprofessionals help with lunch delivery to the classroom.
- 3. Tasha Hartley said they have to be accurate as to who is getting lunch due to reimbursement guidelines.
- 4. It was also brought up, while kids are in school would parents still pick up meals in the same place. Yes, we were wondering if there is a space closer to the circle, such as the band entrance.
- 5. There was also discussion about the potential to deliver lunches for those who cannot get to the school.

Transportation - Deb Burkott - Lead Person Committee members - Steph Fisk, Melissa Nazzaro, Linda Coffey

- 1. There has been some initial guidance for the summer program. Right now a 71 passenger bus holds 24 students if 3 feet of distance works.
- 2. Dave Hopson has a meeting with the commissioner so maybe we will have more guidance.

Facilities - Ed Quinn - Lead Person

- 1. Both touchless water stations have been installed. 4 more have been ordered and should arrive next week.
- 2. Laura Fisk brought up the fact that the student desks with the cages do now work well in classrooms as items are constantly falling out. Melissa Nazzaro suggested that we use the cage desks in the cafeteria if we are eating in the cafe versus the classroom or altering them for classroom use.
- 3. There was discussion about visual reminders for students for desk placement, hallway markers etc. Megan has ordered colored painters tape for the elementary.
- 4. Jason Finnie is planning on doing a survey asking teachers what needs to come out of their classrooms that is extra.
- 5. Ed Quinn had concerns about storage. Jason Forgue asked about the storage containers. And it was determined that they are not usable as they do not have ventilation and they are not in good enough shape to install ventilation.
- 6. Michele Crane thinks this is feeling less like a school and more like a jail. She would like to create a plan that gets those who want to stay home to come instead of online learning. She is wondering how much is recommended, required and just smart.
- 7. Steph Fisk said DESE's recommendation was to eat in the classroom and we were trying to get students in a group by having the cafe open. When masks are off the distance is 6 feet, but in the classroom it is 3 feet. The round tables are 5 feet across.
- 8. Megan Coburn said lunch is a social opportunity for the elementary and if they are all facing the same way, that is lost. If they stayed in the classroom they are more likely to engage and be social.
- 9. Jason Finnie said unfortunately that just doesn't work in the high school.
- 10. Russell and Blandford was brought up as possible storage spaces.
- 11. Michele Crane said we are going to need to educate parents on cohorts and what a school day is going to look like.
