# V. PRESENTATIONS/REPORTS/RECOGNITIONS

#### A. FY '15 Budget Presentation – Principals

- Mrs. Eliason reminded everyone that Mrs. Blocker and Ms. Taverna gave their presentations last week and the principals are giving their presentations this week. She also thanked the administrators for putting these presentations together.
- Mrs. Coburn gave an elementary/middle school budget presentation.
- Mrs. Laurie asked what language they were learning. Megan said the program is called Sketch Up and they were using a lot of math language and she doesn't think they even realize it.
- Mrs. Levreault asked if Chester students would be able to come to Littleville for tutoring in the summer.

- Mrs. Coburn said Mrs. Blocker is looking at having a title I program in Chester.
- Mrs. Eliason thinks bringing students in early for assessments is interesting. Would it be the classroom teachers who come in to administer the assessments?
- Mrs. Coburn said we would probably post internally for facilitators. The students that don't come in can always be taken care of by the reading specialist once school starts.
- Mrs. Eliason asked where the money comes from.
- Ms. Fisk said it's under tutoring.
- Mrs. Winer asked if we will wait a year to assess them again.
- Mrs. Coburn said we assess all students in the fall, then again in the winter to see where those students are and to make sure students are making effective progress.
- Mr. Finnie gave a Jr. high and high school budget presentation.
- Mrs. Winer asked about study Island.
- Mr. Finnie said it's a tool used to provide more opportunities for students who need pull out remediation.
- Mrs. Kennedy asked if what is being done about the kids that are thinking about leaving school. What is being done to get them to stay?
- Mr. Finnie said they are finding ways to promote career readiness. Being more hands on; intro to
  technology and woodshop are two examples. Guidance works with them during advisory. A suggestion is
  to organize advisory by career interest.
- Mrs. Eliason asked if Mr. Finnie could talk about online learning
- Mr. Finnie said a lot of the classes are languages. Some are technology and entrepreneurial. It continues to grow. There are around fifteen students taking online courses per semester.
- Mrs. Eliason asked if the students were working on individual laptops. She notices our line item is down.
- Mr. Finnie said yes they come here to the library.
- Mrs. Laurie said students can't do online learning at home, it is a blocked off period during the day correct.
- Mr. Finnie said most are full time students here only taking one online course. We do have students who
  participate in dual enrollment.
- Mrs. Kennedy notices there are a lot of purchases of pencils and erasers, throughout the year. But there are also notes that go home saying they need them. Is there any way to know how many. Can we budget and then ask if we run out.
- Mrs. Coburn said when the bid list comes out we try to order all our core supplies. We do use them, and some students literally eat them. We go through them so quickly.
- Mrs. Kennedy asked if it would help to put more in the budget to help fund them.
- Mrs. Coburn said supplies are necessary. It would help.

#### VI. COMMUNICATIONS

#### A. Student Representative

• John Wyand said as part of student school climate they have had training on healthy relationships, and they have two teaching classes next week. NHS is going to elementary schools to read to students for Dr. Seuss day.

#### **B. School Committee**

• Mrs. Kennedy understands everyone received an invitation to the PARCC meeting on Saturday, March 15 at 9:00 a.m. at Smith Vocational. She is planning on attending and hopes others will join her.

#### C. Chairperson

• Mrs. Eliason reminded school committee that one of our goals is that everyone take the ethics training. She feels if you take it you will understand conflict of interest. She thinks it is being used incorrectly. Another goal is to take MASC's charting the course. It is a state requirement to take within the first year of being elected, but we have added veteran members should take it every 8 years.

# D. Superintendent – Central Office Update (Enc.)

- Dr. Hopson said we are going to start a committee to come up with district determined measures. We held a drill today. It was a lockdown drill that only took about 10 minutes. The drill went well.
- Mrs. Laurie said students noticed there was a number system echoing through the halls.
- Dr. Hopson said it is a distress noise, to let staff know there is something going on.

- Ms. Fisk said it covers all trips to away games and meets. It will come out of the revolving account.
- Mrs. Laurie asked about the difference in lunch monitors.
- Ms. Fisk said they cover lunches and the lunch of the security monitor.
- Mr. Finnie said one of the duties of the guidance is to cover the lunch room.

#### D. Legislative Liaison

- Mrs. Kennedy asked to have legislative updates added to the adhoc reporting section.
- Monday, Mrs. Kennedy went up to Lenox to talk to Senator Downing and Representative Pignatelli and they discussed the Worthington withdrawal and other things. It is still on hold right now. Looking into the process specifically how it will affect the other towns. She asked about unfunded mandates they are aware of them and want to do something about it. They were interested in changing the formulas for assessments. They would be open to us to send unfunded mandates.

#### **B.** Parking Fees For Walkers

- Mrs. Eliason explained this is for students who are not eligible to ride the bus because they are walkers. Should they pay a lesser fee?
- Dr. Hopson said right now they are not paying because we need to make a decision.
- Mrs. Levreault said when we looked at parking fees we looked at a lot different options.
- Mr. Kronholm said it would be simpler if we didn't have any parking fees.

# Mrs. Laurie made a motion to eliminate all parking fees – there was no second.

- Dr. Hopson agrees with Mrs. Laurie, however, if you are going to eliminate parking fees you should eliminate all fees. This is just a way to self sustain some of these things. When we did this, Mrs. Kennedy was there, at the time it was a flat fee. They met with student council and came up with a way to reduce the cost for students, if they get good grades, have no tardies etc.
- Mrs. Eliason said we revised it. At first you got a rebate if you weren't late, then you were eligible if you were not late and made honors as an incentive for students to lessen the burden.
- Mrs. Kennedy asked how much of the \$10,000 is rebated.
- Ms. Fisk will get her a figure.
- Mrs. Winer said part of the problem is we pay for a seat on the bus, they don't use.

- Dr. Hopson said the walkers don't have a seat on the bus. His recommendation is to charge walkers half.
- Mrs. Foley said, so it is paying for a seat on the bus and for maintenance to the grounds.
- Mr. Wyand said what if we waive the fee, but if they are tardy they have to pay.
- Mr. Finnie wouldn't want to make anything around parking a consequence.
- Mrs. Levreault understands why the parking was initiated, but you have to look at repair and upkeep.
   Parking at school is a privilege. Students are entitled to refunds. We do have to use it and line it.
   Everyone should have to pay for parking.
- Mrs. Laurie said we are going to have to maintain the parking lot no matter what.
- Mrs. Eliason reminded everyone if they have a student parking they should disclose it.
- Mrs. Otterbeck's daughter is too cheap to pay to park. She feels it is a privilege to have a car and park.

# Mr. Kronholm made a motion seconded by Mrs. Levreault to have one universal policy/fee for students who drive.

- Mrs. Kennedy said if you make it universal you are including everyone. Mrs. Kennedy feels the student council should have a change to weigh in on this.
- Mrs. Coffey said one of the reasons the parkers need to drive is because the sidewalks are not clear.
- Dr. Hopson said once they start driving, they will most likely continue to drive.
- Mrs. Foley asked why the sidewalks aren't cleared.
- Dr. Hopson said it is a town/state issue. Huntington has been winging back the snow banks. Our sidewalks are clear
- We are changing the word universal to consistent.

# Mr. Kronholm made a motion seconded by Mrs. Levreault to have one consistent policy/fee for students who drive.

# C. Mid-Year Superintendent's Formative Assessment Review

- Mrs. Eliason said she has no way to score impact on learning.
- Dr. Hopson said as the state comes through with how they are going to use district determined measures there will be ways to look at that. There will be a specific ways to measure this.
- Mrs. Eliason said what I do not know as a school committee member how that analysis how many action plans were developed.
- Dr. Hopson said that is input on formative assessments. Here is what we are looking for to better instruction.
- Mrs. Eliason said we need to look at a five year and ten year capital plan.
- Mrs. Eliason is not sure what the status is on core curriculum. It is hard to know what the full scope is maybe we need a progress bar. Training opportunities who administrators.
- Mrs. Blocker said we are developing a 7 year plan which she will be share. She also she has actions plans.
- Mrs. Eliason said at the end of year, how do we know if teacher evaluations have been done?
- Mrs. Eliason asked if there are any other plans besides the new math curriculum
- Mrs. Eliason asked about the educational leader promotes safe effective learning, she does not have a grasp on these tools.
- Dr. Hopson said it is part of school committee's job.
- Mrs. Eliason asked about human resources. Pupil services mentioned four new staff members. How are we dealing with turnover?
- There seems to be a concern with staff turnover. Is it due to pay scale, are people just not happy. There seems to be a lot of staff turnover. Maybe it would be helpful if it was broken down year by year.
- Dr. Hopson said happy people don't leave for pay. Happy people can be happy anywhere. There are retirements, some get experience and then move closer to home with bigger pay.
- Mrs. Laurie asked if we would take into consideration, the hiring of teachers who don't live so far away.
- Dr. Hopson said we hire the best staff we can. We hope they live close, and if they don't maybe they will move here.
- Mrs. Winer said it would be helpful if it is salary we need to do something about it. It is a function of the type of survey it is. There will be questions we can't answer.
- Mrs. Laurie suggested have Dr. Hopson send written responses to all of Mrs. Eliason's questions to save time.

- Mrs. Eliason said we do have a mid-year management meeting as part of the superintendent's evaluation.
   We need to think about what questions we need to ask Dr. Hopson in a mid-year review.
- Mrs. Kronholm asked what Dr. Hopson would add if there was a five % increase in the budget.
- Dr. Hopson would go back to the administrators. He doesn't always know what they need. He relies on working with the administrators and the GTA to bring a better education to students.
- Dr. Hopson said a statement that is broad is useless, he would like more. For 19 years we have been looking at how school committee evaluates themselves, the state has an evaluation process for teachers, and administrators, but not the school committee.
- Mrs. Eliason said we did talk about goals, we did say we would do an end of year report to the towns,
- Mrs. Winer doesn't recall voting on that. Not that it is not good; it is more of a report to ourselves.
- Mrs. Laurie asked if it was a self-evaluation or is it done by the administration.
- Dr. Hopson said we talked about school committee communicating with the towns, how do we
  communicate with each other, the towns, how do we work together to move the district forward. The key
  should be students.

- Mrs. Eliason said the question is will Mr. Jacques be on the at the table negotiations team; the one we voted in November.
- Dr. Hopson said the law states he sits on the committee to vote. Because we are collaborative bargaining we need to get the GTA to approve Mr. Jacques to sit at the table.
- Dr. Hopson said you can waive the two-meeting rule to put him on the negotiations subcommittee.
- Mrs. Kennedy wants to make sure it is clear that there is no fault to the select boards for not being on the committee earlier. We should have notified the select boards before negotiations started.

Mrs. Buikus made a motion seconded by Mrs. Kennedy to suspend the two-meeting rule.
